#### **Data Collected Automatically**

When you visit and use our Site, we may automatically collect and store the following information:

1. Clicked links; and
2. Email Address / Personal Contact Information When Submitted through Contact Forms.

#### **Data Collected in a Non-Automatic Way**

We may also collect the following data when you perform certain functions on our Site:

1. First and last name; and
2. Email address.

This data may be collected using the following methods:

1. Through Email Subscription Forms.

### **How We Use Personal Data**

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for the following purposes:

1. As Allowed Only (RE: Email Subscriptions with Opt-Out Option).

The data we collect when the user performs certain functions may be used for the following purposes:

1. For Email Subscription Notifications.

### **Who We Share Personal Data With**

#### **Employees**

We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.
