## **Measures to Support Accessibility**

GoodPud's website (<u>www.goodpud.ca</u>) is **partially conformant** with WCAG 2.1 Level AA. *Partially conformant* means that some parts of the content do not fully conform to the accessibility standard.

We are actively working to achieve full compliance and continuously monitor the site to address accessibility issues as they arise.
